Convicted on 04/26/90 of indecent A&B on a child

[REDACTED] has lived in Framingham since 1985. He was living in the Chapel Hill apartments when he committed his offense. He is not involved with any social services and was arrested in 2002 for accosting women.

[REDACTED] 13 Haven Street Framingham

Convicted of open and gross & lascivious behavior on 12/16/88, Indecent A&B Child under 14(2 counts) and rape and abuse of a child 04/24/91, and indecent A&B on a child 07/19/93.

[REDACTED] was living on Highland street in Framingham when he committed his offense in Milford. He grew up in Framingham and has lived here for 22 years

[REDACTED] Homeless.

Convicted of rape and indecent assault and battery on a person 14 or older on 04/25/95  
I have not been able to locate [REDACTED]

[REDACTED] Homeless

Convicted of indecent assault and battery on a child on 09/25/02  
[REDACTED] told me he lived in Framingham from 1962 to 1986. He moved to Whitinsville. [REDACTED] who was recently kicked out of the shelter for refusing to go to a program for the hearing impaired informed me that he learned about the shelter from his good friend [REDACTED]

[REDACTED] Homeless

Convicted of rape of a child (3 counts) and indecent assault and battery on a child Under 14(3 counts) on 07/20/95

[REDACTED] was recently released from South Bay. He moved to Framingham 3 months ago because his family felt it would be safer for him. His family feared for his safety because his name kept being put in the paper. [REDACTED] stated he stays at the shelter sometime but it gets crazy in there so he stays outside. He is also registered in Cambridge, he has PO Box there.

Indecent Assault & Battery on a Child under 14 on 11/18/02

[REDACTED] was living in Medfield and committed his crime in that town. After serving time in Norfolk County he lived in a veteran's shelter in Boston. He moved to Framingham four months ago. [REDACTED] states he moved to Framingham because he lived here eight years ago.

[REDACTED] 316 Hollis Street Apt. [REDACTED] Framingham

Convicted of rape of a child on 02/14/78

Recently the victim of a violent domestic could not be located

[REDACTED] 276 Main Street Marlboro, Ma

Convicted of three counts of rape and abuse of a child on 03/22/92. [REDACTED] works at labor ready I have not been able to contact him.

[REDACTED] 8 Cottage Ave Marlboro, Ma

Convicted of open and gross lewdness a lascivious behavior on 08/25/75. Convicted of 4 counts of rape of a child, 5 counts of assault and battery, and 7 counts of indecent assault and battery on a child under 14 on 10/27/92

[REDACTED] lives in Marlboro he works in Framingham at 92 Blandin Ave.

[REDACTED] 12 Lexington Street Apt. [REDACTED] Framingham Ma.

Convicted of rape of a child with force on 04/26/95 and rape and abuse of a child on 08/01/01.

[REDACTED] committed his offenses in Fall River. He spent time in Concord and Bridgewater. When he was released the Pine Street Inn in Boston was full so he took the Train out to Framingham and found the shelter. He has lived in Framingham for the past three years.

[REDACTED] 134 Arlington Street Apt. [REDACTED] Framingham

Convicted of two counts of Aggravated indecent assault & Battery on a child under 14 on 10/11/95.

[REDACTED] stated he moved to Framingham 10 years ago from Boston. He told me that he was dealing drugs and was on parole when he moved to Framingham. He stated he moved to get a fresh start. He was living in town when he committed his sex offense. He served time in Concord, Gardner and South Eastern. Upon his release from prison he returned to Framingham.

[REDACTED] 46 Irving Street, Apt. [REDACTED] Framingham

Convicted of rape and abuse of a child 04/11/85

[REDACTED] committed his offense in Alston, Ma. He served only three years of a nine to fifteen sentence. Upon being released he moved to Boston. [REDACTED] states he was sent to Framingham by the Parole board after he violated his parole twice in Boston. When he first moved to Framingham he lived at 105 Irving Street.

[REDACTED] 166 Irving Street, Framingham Ma.  
Convicted of rape on 03/14/91

[REDACTED] is originally from Newton MA. He bought a house in Framingham on Wild ave. When he was in pre release he lost his house. He is involved in SMOC housing. The department has recently received complaints from some [REDACTED] neighbors about his involvement in the sale of illegal drugs.

Convicted of indecent assault and battery on child under 14 on 07/26/02, indecent assault and battery on a person 14 or older on 11/20/95, and open and gross lewdness/lascivious behavior on 09/26/90

[REDACTED] 140 Union Ave. Apt.  
Convicted of rape on 01/25/90

[REDACTED] was living in Brockton, Ma at the time of his Offense. He committed his Offense in Plymouth. He served time in Walpole and Concord. He moved to Framingham four years ago. He moved because his sister lives in town and told him it was a nice place to relax. Since moving to Framingham Mr. [REDACTED] states he has been arrested three or four times for domestic A&B. He was also arrested for selling a fake substance. Mr. [REDACTED] told me he is not currently involved with any social services; however he is in need to see a psychiatrist.

[REDACTED] 63 Kendall Street, Framingham, Ma  
Convicted of two counts of assault to rape and indecent assault and battery on a child under 14 on 11/16/87.

[REDACTED] was living in Dorchester, Ma when he committed his offense. His crimes were committed in Boston. After serving time in Concord and Old Colony he was paroled. [REDACTED] stated that parole set him in Framingham with an apartment at 92 Irving Street. He currently is not involved in any social services; he does however attend AA meetings.

[REDACTED] 40 Berry Street Framingham  
Convicted of indecent assault and battery on 10/03/97 and 05/04/99

[REDACTED] stated that her brother does not live in Framingham, he only uses the address. She told me he lives in Marlboro. I have been unable to contact Mr. [REDACTED]

[REDACTED] Homeless.  
Convicted of indecent assault and battery on 03/19/75 and five counts of open and gross lewdness and lascivious behavior on 12/04/02

[REDACTED] was not very cooperative during my interview. I spoke to him in the parking lot of Dunkin Donuts on Franklin St. He was pre occupied begin people for money.

[REDACTED] Homeless

Convicted of rape and abuse of a child on 12/19/2000

Lieutenant Wuorio believes [REDACTED] may be incarcerated.
